


#### Survey responses summary, April 2024

The main of the Humanitarian assistance encompasses is a wide range of activities aimed at saving lives, alleviating suffering, and maintaining human dignity during and after crises. The main types of humanitarian assistance include: 1. Emergency Relief: - Food Assistance: Providing food to people in need to prevent hunger and malnutrition. - Shelter and Non-Food Items: Supplying temporary housing, tents, blankets, and essential household items. - Water, Sanitation, and Hygiene (WASH): Ensuring access to clean water, sanitation facilities, and promoting hygiene practices to prevent disease outbreaks. 2. Health Services: - Medical Care: Offering emergency medical treatment, vaccinations, and support for health care facilities. -Psychosocial Support: Providing mental health services and counseling to help individuals cope with trauma and stress. 3. Protection: - Safety and Security: Ensuring the safety and protection of vulnerable populations, particularly women, children, and refugees. - Legal Assistance: Offering legal aid and support to protect human rights and access to justice. 4. Education: - Emergency Education: Setting up temporary learning spaces and providing educational materials to ensure continuity of education for children during crises. 5. Livelihood Support: - Economic Assistance: Providing cash transfers, job training, and support for rebuilding livelihoods to help people recover economically. 6. Coordination and Logistics: -Supply Chain Management: Ensuring efficient delivery and distribution of humanitarian supplies. - Coordination: Facilitating coordination among various humanitarian actors to optimize response efforts and avoid duplication. 7. Disaster Risk Reduction and Preparedness: - Preparedness Activities: Training communities to respond to disasters and supporting early








