## **Profile**

Greetings to all. My name is Nancy Etté and I am a British national who has lived and worked internationally for over 30 years – which I realise ages me somewhat! Having started my professional life in Japan, I went on to work for non-profits in Norway and later in business management in the private sector in Switzerland. Wanting to return to more value driven work, I took the leap to join the Norwegian Refugee Council in Geneva (2015–2021) as Head of Support, overseeing local finance, HR, IT, and administration for NRC, IDMC and ACAPS. Alongside this, I participated in several internal audits in Africa and the Middle East, helping to strengthen controls, compliance, and risk management across field operations.

From 2021 until June 2025, I served as Director of Operations at ACT Alliance, with responsibility for finance, HR, risk, and compliance at the global Secretariat, including oversight of it's regional offices and Humanitarian Mechanism. I worked closely with the finance team and Board Treasurer to ensure responsible financial management of both member and donor funds, managing the annual audit processes and regularly presenting to the Board on operational matters. I was also ACT's focal point for the Core Humanitarian Standard (CHS), embedding quality and accountability principles into policies, operations, and member engagement.

Since 2023, I have been a member of the Finance, Risk and Audit Committee of the CHS Alliance, contributing directly to oversight of financial reporting, audit, and risk management.
